1. Course Title : Human Rights in India

2. Context

Human Rights are a broad area of study which focuses on protecting those basic rights of the individuals to which everyone is entitled. These are universal rights inherent to all human beings regardless of their nationality, religion, caste, ethnicity, language, gender and any other status. The Universal Declaration of Human Rights (UDHR) adopted by the General Assembly of the United Nations in 1948 was the first legal document that set out the fundamental human rights that needed to be protected.
